
Schedule Zoom Calls or Request In-Person District Meetings with Your State Senators

What does it mean when we ask them to be a Senate Champion?

They're agreeing to:

- Take any measures they can to urge the Senate to preserve these programs in their budget.
- Be identified as the Senate champion for preserving these programs, when coalition members are in discussion with members of the legislature and the Administration.
- Be listed on the [stakeholder budget request form](#) for Senate budget subcommittee 3 (Human Services) as the Senate Champion. *This does not count against any other limits on a Senator's budget requests that may exist but is meant to demonstrate support within the Senate

You may also mention:

- Assemblymember Ting, the Assembly Champion gathered 24 signatories from fellow members of the Assembly on a letter identified preserving this program as a priority.
- Given the more conservative parameters of the Senate in budget letter circulation this year, the coalition is not asking for a senate letter, but hoping for several Senators who will identify as champions in name.

DSS has proposed a new foster care rates structure, as required by state law

Overview

- The California Department of Social Services (DSS) was required to reform foster care rates by 2025. They've issued Trailer Bill Language and a proposed framework for what this will look like.
- They've indicated the changes are based on the needs of the child, not based on where they are placed.
- Children and youth will be assigned "Tiers" based on how they score on the Integrated Practice-Child and Adolescent Needs and Strengths (IP-CANS).
- Each Tier will have a "Care and Supervision rate" assigned to them, then some children and youth will be eligible for additional funding on top of that rate, depending on their Tier.
- The Trailer Bill Language pushes the 2025 date out to sometime between 2026-2028, for when these new rates would take effect.

What would this look like for youth in SILPs?

- Youth in SILPs will automatically qualify for Tier 1 only (youth in other placements may qualify for Tiers 2, 3, or 3+)
 - The Tier 1 Care and Supervision Rate is \$1,788 (up from the current SILP rate of \$1,206)
- Youth in SILPs may qualify for **one** of the three potential other types of funding:
 - ✓ **“Strengths Building & Maintenance”** which may be used for extra-curricular activities, education and skill building support, mentoring/engagement of family/community. Youth may access an additional \$500/month for these activities, managed by a financial management coordinator.
 - ✗ “Immediate Needs” (youth in SILPs not eligible)
 - ✗ “Admin” (this is for FFA and STRTP providers only; youth in SILPs not eligible)

What we know, and what we don't know

- **Questions remain regarding Strengths Building funds:** Its unclear **how accessible** the Strengths Building funding (\$500) will be, **how youth in SILPs will make use of it** (considering any expenses must be paid by a “spending plan manager”) and **what expenses would be approved.**
- **DSS' rates proposal is an improvement:** Based on the SILP Care & Supervision Rate proposed, all youth in SILPs would receive a higher monthly rate than they are currently **(\$1,788 v. \$1,206).**
- **DSS' rates proposal does not replace the need for the SILP Housing Supplement:** 2,111 youth across 22 counties would still receive a rate that is less than what the SILP supplement would provide them when applied to the existing rate. **This equates to 66% of all youth in SILPs.**
- **When applied together (new rate + SILP HS), youth in SILPs will fair better:** Increasing the SILP rate also increases the SILP Housing Supplement for **99.7%** of youth in SILPs. If the methodology for the SILP Housing Supplement is applied to the new SILP rate, the highest monthly SILP payment (Santa Cruz) would be \$2,898, as opposed to \$2,557.

DSS' Trailer Bill Language phases the SILP Housing Supplement out starting in 2028

- DSS' Trailer Bill Language phases out the SILP Housing Supplement in 2028 because existing statute ties the SILP Housing Supplement to the rates being phased out.

How do we ensure the SILP Housing Supplement Does Not Phase Out?

- We request amendments to DSS' Trailer Bill Language, tying the SILP Housing Supplement to the new care and supervision rate that youth in SILPs will receive.
- We continue to fight to preserve the funding for the SILP Housing Supplement in the state budget—the good news is, the new SILP rate makes the supplement less costly starting in 2028!
