## **Email Senator Menjivar & Assemblymember Jackson this Week**

- At the April 25<sup>th</sup> Senate budget human services hearing, an option was raised in attempt to find a middle ground between the SILP Housing Supplement and what is proposed under rate reform.
  - Unfortunately, the option is NOT a middle ground and would not achieve the goal of preventing homelessness among foster youth in SILPs.
- Its important that we communicate to the chairs of the budget subcommittees on human services in both the Senate and the Assembly that this option is a nonstarter.

## Prepare to e-mail Governor Newsom early next week

- The May Revise will likely be released tomorrow, with possible additional details provided Monday.
  - We do not anticipate that the SILP Housing Supplement or the Housing Navigation & Maintenance Program will be restored in the 2024-25 budget.
- Its important that we send a loud and clear message to the Newsom
  Administration that these cuts will hurt young people and lead to homelessness.
